EPA RULE ON AIRBAG STORAGE

In their 2018 interim final rule, the US EPA states that **airbag wastes must not be accumulated in quantities of more than 250 airbags** (One drum of bare inflators or two skids of boxed modules) **or for more than 180 days.**

To stay clear of **full** hazardous waste regulation airbags need to be properly handled and disposed of in a timely manner. **We can consult on the best way to manage and accumulate airbag modules and inflators to keep you off local and state regulators' radar.**

RESPONSIBLE AIRBAG STORAGE
